Terms and Conditions of the promotional contest Visa Olympic & Paralympic Games Paris 2024

(the "Contest Rules")

(English version)

Article 1. General Terms and Conditions

- **1.1.** The Belgian company VISA Europe (Belgique) S.R.L., whose registered office is located at 8 Rue de Spa 1000 Brussels, Belgium, registered with the Banque Carrefour des Entreprises under the number 0800.108.359 (hereinafter the **"Organising Company"**) is organising a contest with an obligation to purchase, entitled "Visa Olympic & Paralympic Games Paris 2024" (hereinafter the **"Contest"**).
- **1.2** These Contest Rules govern the relationship between you (the "Participant(s)") and the Organising Company regarding the Contest. Participation in the Contest implies express and unreserved acceptance of these Contest Rules in all their provisions. Please read these Contest Rules carefully before participating. If you do not accept the Contest Rules, you cannot participate in the Contest.

Article 2. Contest Duration

2.1. The Contest begins on 15 January 2024 at 00:01 and ends on 10 March 2024 at 23:59 (hereinafter referred to as the "Contest Period") in accordance with the terms and conditions set out below.

Article 3. Eligibility Conditions

- **3.1.** Participation in the Contest is open to natural persons of legal age over eighteen (18) years of age regardless of their nationality and holders of a Visa card issued by a Luxembourg banking institution. The Organising Company reserves the right to ask Winners (as defined in Article 6.2 below) to prove that they meet the eligibility conditions for participation in the Contest.
- **3.2.** Members of the staff of the Organising Company and any company or service provider participating, directly or indirectly, in the implementation of the Contest, as well as members of their families, including cohabitants, are not authorised to participate in the Contest.
- **3.3.** This Contest is aimed solely at the Luxembourg territory, without prejudice to other promotional contests for which the conditions will be determined by the Organising Company in other territories.

Article 4. How to Enter and how the Contest is Run

- **4.1.** To take part in the Contest, Participants must:
- (i) register on the www.visaeurope.lu/campaign/national-contest-visa-Paris2024/en website, and
- (ii) fill in an entry form with their name, surname, e-mail address, and their Visa card's principal account number (PAN) and meet the Contest criteria (as specified below in Article 4.2.) to have a chance at winning one of the Prizes at stake (as defined in Article 5.1 below),

Participants only need to register once on the www.visaeurope.lu/campaign/national-contest-visa-Paris2024/en website to take part in the Contest during the Contest Period.

- **4.2.** Once the Participants have completed the procedure in Article 4.1. and to try to win one of the Prizes at stake each week in the draws to be carried out by the Organising Company (as defined in Article 5.1 below), the Participants must meet the following participation criteria (the "Participation Criteria"):
- (i) make at least one (1) payment with their Visa card, regardless of the amount of the transaction, to be eligible to take part in the prize draw for the week concerned during the Contest Period; and
- (ii) make that payment either:
 - through their digital wallet, or
 - via a cross-border payment, or
 - through an e-commerce site.

Article 5. Number of Prizes at Stake

- **5.1.** The total number of prizes offered by the Organising Company during the Contest Period is sixteen (16) (hereinafter the "Prizes").
- **5.2.** During the Contest Period, the Organising Company will award two weekly Prizes, namely a first Prize (8 first prizes in total) and a second Prize (8 second prizes in total).
- **5.3**. During the weekly draws, Participants who meet the Participation Criteria detailed in Article 4.2. could win either:
 - a First Prize, which is composed of two tickets for the Winner and an accompanying person to a Paris 2024 Olympic Games event; or
 - a Second Prize, which is two tickets for the Winner and an accompanying person companion to a Paris 2024 Paralympic Games event.
- **5.4.** The Prize excludes insurance for the Olympic or Paralympic tickets, travel costs to the event, and accommodation. Any service not included in the Prize described above and which the Winner (see below Article 6.2) concerned would like to take advantage of is at their sole and exclusive expense.

Article 6. Award of Prizes

6.1. The allocation of these Prizes, by drawing lots, will take place each week and will be carried out by a Bailiff from the Calvo & associés firm (65 Rue d'Eich, L-1461 Luxembourg) in the following way:

- **6.2.** It is understood that the order of winner selection will follow the chronological order of the random drawing of entries. During the weekly draw, the first Participant drawn at random will be awarded the first Prize, and the second Participant drawn at random will be awarded the second Prize (hereinafter referred to as the "Winners").
- **6.3.** Participants in the Contest will be contacted by e-mail by the Organising Company at the end of the weekly Prize draw withing the dates provided in the table above, provided in clause 6.1 in the column Winner Notification, to allow the Organising Company to verify the Participation Criteria as.
- **6.4** Once notified, Winners must follow the steps below to claim their Prize:
 - 1) Accept the Prize by acknowledging the e-mail received from the Organising Company by April 4th 2024 23h59 by replying to the e-mail contest@visa-paris-24.com received from the Organising Company.
 - 2) From April 2024, register on the Visa Guest Registration Portal by clicking on the link provided in the email wisaevents@sidlee.com sent by Sid Lee London on behalf of Organising Company The Winner must register before 22 June 2024. The link will redirect Winners to a registration form where relevant information about Winners and the accompanying person will be collected. Instructions for downloading the official Paris 2024 ticketing application will be provided.
- **6.5.** If the Organising Company is unable to contact the Winner at the end of each Prize draw, or if the Winner contacted does not claim their Prize within seventy-two hours (**72h**) of receipt of the e-mail from the Organising Company under the conditions provided for in Article 6.4, the Prize in question shall be considered abandoned and shall not be put back into play.
- **6.6.** The Prize is personal to the Winner and may under no circumstances be transferred or sold to a third party, nor may it be the subject of any financial consideration whatsoever.

Article 7. Limitation of Liability

- **7.1.** The Organising Company shall not be held liable for any events for which it is not responsible, particularly in the event of force majeure or events beyond its control that may affect the Contest.
- **7.2.** If, in such circumstances, the Organising Company were to have to shorten, extend, postpone, or modify the duration of the Contest or cancel it, it will put in place the technical means necessary to inform the Participants.
- **7.3.** The Organising Company reserves the right, if circumstances beyond its control require or, more generally, for any reason whatsoever, to modify the Prize and replace it with a prize of at least equivalent value without its liability being incurred in this respect.
- **7.4.** The Organising Company declines all responsibility in the event of non-compliance by the Winner with the conditions of participation in the Contest and use of the Prize won, and in particular, each Participant is solely responsible for the data they enter. Each Participant is responsible for checking their e-mail box and spam box during the Contest Period and the periods following the weekly Prize draws per the table in Article 6.1.
- **7.5.** In any event, the Organising Company has no liability to Participants other than that which cannot legally be excluded, and no compensation may be claimed from it by Participants.

Article 8. Severability

8.1. If one of the Articles of these Contest Rules is declared null and void, this shall not affect the validity of the other Articles.

Article 9. Processing of Personal Data

Visa and its associated companies as a data controller and service providers may collect, process, use, and share information from or about the Participants and any guest for fulfilment and delivery of the Promotion and the Prize.

The Winners are responsible for making their guests aware of these Terms and Conditions and Visa's privacy policy.

Visa processes the Participants' personal information as necessary for the performance of a contract (as set out in the terms and conditions). 10.1. The determination of Winners does not give rise to any appeal, subject to the mandatory provisions of the law.

Article 11. Language and Applicable Law

- **11.1.** The Contest, the Contest Rules, the registration form on the www.visa.europe.lu website, and the promotional material for the Contest are produced in French and English.
- **11.2.** The Contest, the Contest Rules, the registration form on the www.visaeurope.lu/campaign/national-contest-visa-Paris2024/en website, and the promotional material for the Contest shall be governed by and interpreted under Luxembourg law.
- **11.3.** The Organising Company is solely competent for the interpretation, implementation, or execution of these Contest Rules.
- **11.3.1.** The Participants and the Organising Company shall attempt to amicably resolve any dispute that may arise in connection with these Contest Rules.
- **11.3.2.** Any dispute arising out of or in connection with the Contest that cannot be resolved amicably shall be subject to the exclusive jurisdiction of the courts of Luxembourg City unless otherwise provided for by public policy.

Article 12. Submission and Consultation of the Contest Rules

- The postage costs incurred in sending the rules will be reimbursed at the cost of a stamp at the current rate within four (4) weeks of receipt of the written request and with a limit of one reimbursement per household (same name, same address).
